# What does EU Services Directive mean? Compelling Event for 2009!

**SIEMENS**



- Service Provider can offer their Service European-wide
- Therefore, Service Provider shall register his business through one administrative step in the respective country
- Major IT consequences!!!

# The IT-Implementation of the EU Services Directive focuses on three main measures

**SIEMENS**

## Point of Single Contact



Responsible for all proceedings and formalities, necessary to start a business:

- Gate to the different administrations
- Enable providers to obtain information
- Complete all procedures and formalities

## Electronic proceedings



Member States have to ensure that all procedures and formalities may be easily completed by electronic means:

- Cross-country and cross-administrative IT solutions
- Processing without Media discontinuities

## European mutual assistance



Realization of the EU Internal Market through European mutual assistance between Member States:

- Internal Market Information System (IMI)

# SPOCS : Simple Procedures Online for Cross-border Services

- The objective is to build on MSs' activities as they implement Art. 8 and other appropriate articles of the Services Directive 2006/123/EC.
- The aim is not to delay the implementation of the Services Directive but to provide complementary key interoperable building blocks by taking stock in MSs' activities as they implement the Services Directive.

- Security and tracking data exchanges between EU administrations

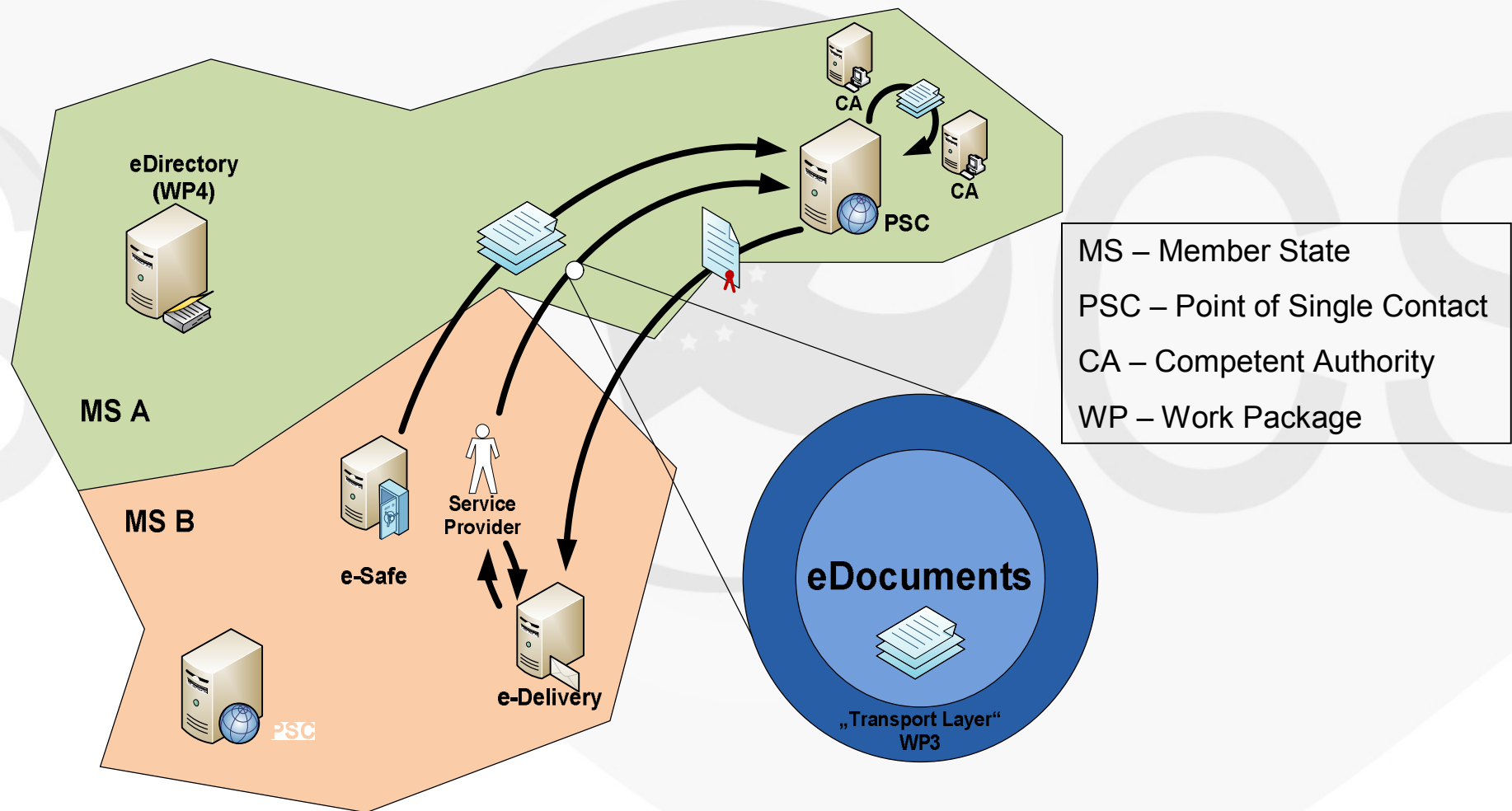


The specifications developed will be integrated and tested:
