

Why SAF-T?

- Make more efficient and effective tax inspections
- Simplify identify non-compliance in tax reporting within a few minutes
- Reduce the periods of VAT Return

According to data from the Ministry of Finance, a total of EUR 6 billion was recovered in 2016-2018 Greater control effectiveness

In 2017, there were over 1/3 fewer controls conducted, while the number of detected irregularities increased

The average duration of a VAT refund decreased by almost a week in 2017. The value of withheld returns has decreased from EUR 800 million to EUR 400 million



SAF-T on Azure

- SAF-T files are ENCRYPTED between Sender -> Azure
 -> MoF on-premise Datacenter
- Universal gateway open for different documents type
- High scalability for enormous data traffic based on Microsoft Azure
- SAF-T files are decrypted on-premise, validated and uploaded to the backend core systems for further processing and analysis
- Automatic solution monitoring
- Development and test environments on Azure with DevOps






"Twój e-PIT"

- Solution for previewing, editing, and accepting pre-prepared annual tax returns and making corrections if necessary.
- → A full web solution.
- → If the taxpayer does not take any action the income tax return provided is considered as accepted by the taxpayer at the end of the settlement period.
- Reduced to a minimum the necessity to communicate with the revenue administration
- It allowed to reduce the risk of making a mistake while completing the declaration form
- → It offers taxpayers the possibility to pay the tax on-line as well as to receive a quick refund of tax overpayment.
- Simplify identify non-compliance in tax reporting within a few minutes



Tax Portal solution details

- Information CMS portal
- Authorization of taxpayers and their spouses by Polish gov main Identity Providers
- Proprietary business rules engine with validation mechanisms of the entered data
- Tax return forms
- Payment module integrated with KIR (Polish payment provider). Quick and easy tax payments
- → Running on-premise
- Development and test environments in Azure with DevOps
- Application Insights Azure component that provides Application Performance Monitoring for Tax Portal

AA WCAG 2.0

In the first year of operation of the service, taxpayers submitted 6.9 million declarations through the implemented solution.

Declarations not submitted on time were automatically generated and submitted on behalf of taxpayers.

The declaration can be submitted in 0-2 clicks. Including logging in with a bank profile, the time spent on the declaration does not exceed 5 minutes.

Better results of the Accessibility Report 2018 study (AA WCAG 2.0 level) after implementation. Final score 84%.
