### Sensitive data requires extra security

- an extensive risk assessment is a prerequisite
  - logical and physical dependencies have to be very transparently carved out
  - permanent exchange of legal, technical and operational best practices could drive the development of a harmonized pan-European, transnational cloud
  - Continuous audits and failure reporting will contribute to security as "lessons learned"

#### The Snowden aftermath 1

- There is a big opportunity now for Europe to win the game!
- But at the same time it is the "last battle for Europe's freedom" (Jan Philipp Albrecht)
- The European data protection regime has to become a political reality to break the hegemonial demand of US American jurisdiction.
