Economic response overview

State aid rules

- liquidity to economy
- support SMEs, jobs, etc.

A €540 bn safety net

- SURE: €100 billion support for unemployed
- EIB: €200 bn for companies
- ESM: €240 bn for sovereigns

Complements ECB measures

- €750 bn new measures
- €120 bn earlier

Recovery Plan for Europe

- €750 bn Next Generation EU
- €1100 bn long-term EU budget

Budget flexibility

- 'Escape Clause'
- maximum flexibility

Coronavirus Response Investment Initiative

- unspent cohesion funds
- transfers between funds, regions and priorities



What has changed in cohesion policy since last ITAPA?

- ✓ Just Transition Mechanism Support to territories facing challenges with transition to climate neutrality (Horna Nitra, Košice) – EUR 418 million for JTF in Slovakia
- ✓ CRII modifications immediate and short-term support to crisis response – EUR 1.2 billion for employment maintenance, health system, SME support in Slovakia
- ✓ REACT-EU bridge the gap between first response and recovery approx. EUR 780 million for Slovakia
- ✓ Recovery and Resilience Fund -support the long-term recovery and the resilience of the economy and society focusing on the green and digital transitions – EUR 5.8 billion in grants and EUR 6.3 billion in loans

Progress of legislative negotiations on cohesion policy legal framework for 2021-2027

- ✓ MFF agreement at the European Council in July
- ✓ REACT-EU Entry into force in 1st quarter 2021
- ✓ Common Provisions Regulation (CPR), ERDF-CF Regulation, ESF+ Regulation, Interreg regulation – political agreement by the end of the year, entry into force April 2021
- ✓ JTF entry into force mid-2021

Progress in preparation of programming documents for cohesion policy

- ✓ Informal dialogue started in spring 2019 after publication of SK Country Report with Annex D Commission's negotiation mandate
- ✓ Importance of partnership principle (Code of conduct on partnership)
- ✓ Informal dialogue meetings with the Central Coordinating body on the Partnership Agreement
- Technical meetings on territorial approach, simplification measures, enabling conditions
- Roadmap on administrative capacity building
- ✓ Waiting for first draft of the single Programme Slovakia (with ERDF, ESF+, Cohesion Fund and JTF)
- ✓ Waiting for the first draft of the RRP to ensure synergies



Main challenges and opportunities

- ✓ Single programme Slovakia should not be the only simplification measures
- ✓ Complementarities of OP Slovakia and RRP only a few months left
- ✓ Effective usage of territorial tools, real bottom-up approach for local, urban and regional authorities through territorial strategies key element of the new programme
- ✓ Administrative capacity increase at all levels
- ✓ Robust institutional set-up, strong MA
- ✓ Shortening of procedures while keeping the accountability (simplified cost options, for example)

- ✓ Informal dialogue and submission of mature OP Slovakia
- ✓ SCO schemes
- Enabling conditions

RRF and Cohesion policy- partners or rivals?

- Delivery mechanism: Targets and milestones ex-ante versus costs ex-post
- Thematic concentration: Overlaps and Synergies
- Shorter Implementation period: Challenge for slim project pipelines
- Perspective: the new alternative cohesion policy or pandemic response without longterm future
